BRAZING PROPERTIES:

This 45% silver alloy is a free flowing filler metal that offers excellent joint strength and ductility. It is typically used to braze steel, and in brazing dissimilar metal connections, such as copper or brass to various steel alloys. It exhibits a narrow melting range so a uniform clearance of 0.002" – 0.005" is recommended.

Stay Silv 45 can be a acceptable choice for applications where sufficient fume ventilation/exhaust equipment is in place to assure operators are not exposed to cadmium oxide fume.
